### **(U) Mix of Methamphetamine and Fentanyl, Known As "Sleepy Dope," Present in Pueblo, Colorado, as of February 2019**

SOURCE: (U) A contact who is reporting for the first time.

(U) FBI Denver is disseminating this Situational Information Report to bring law enforcement awareness to a fentanyl-mixed narcotic available in Pueblo, Colorado.

(U//FOUO) As of February of 2019, narcotics dealers and users used the term "sleepy dope" to describe a narcotic available in Pueblo, Colorado. "Sleepy dope" was a mixture of methamphetamine and fentanyl. (FBI Comment. Methamphetamine is considerably less expensive than heroin in Pueblo, and dealers may be mixing methamphetamine with fentanyl in an attempt to increase the heroin user base in Pueblo by addicting methamphetamine users to opioids through fentanyl.)

(U//FOUO) Narcotics dealers are going to needle exchanges in Pueblo, Colorado, to obtain syringes and fentanyl test strips for free and selling the syringes and strips to narcotics users. Users are using the test strips to ensure there is not fentanyl in the methamphetamine they consume.

(U//FOUO) Narcotics dealers are also testing their methamphetamine to make sure it does not contain fentanyl as many of their customers complain when fentanyl is present in the methamphetamine they purchase.
